Emergency Conservation Assistance Program

The Indiana State Soil Conservation Board has awarded the Ripley County SWCD \$28,189.28 in Emergency Conservation Assistance program dollars that will be offered to landowners of Ripley County to help correct the problems associated with the 2008 natural disasters. The District will be offering a cost share program on Soil Sampling, Timber Stand Improvement, Pasture/ Hayland Seeding, and Critical Area Planting. The details of the program have yet to be determined, the staff and board are waiting for more information on the requirements of the grant. South Laughery Creek Streambank Stabilization Field Day

Spring time is right around the corner and with spring comes rain. In our area rain often brings flooding and last year in 2008 Indiana saw record flooding along our streams and rivers. When events like this happen people begin to realize the importance of Streambank Stabilization. Not only are our streams losing their streambanks but more and more sediment is being deposited into the water. Streambank erosion is a natural occurrence but many things that we do speed up the process. For example if a stream has little vegetation to hold onto the soil, the water can easily take that soil rather than leaving it put. By having banks with trees and shrubs you increase the time it takes to erode that soil. Sediment is the number one cause of water pollution and is the main reason this issue needs to be addressed. Most landowners are mistaken and feel that if the stream is on their land, they can do as they wish. However, there are many rules and regulations that apply to our streams. Many organizations enforce these rules and landowners could be fined if rules are broken. **The South Laughery Creek Watershed will be hosting a Streambank Stabilization Field Day on May 7th, 2009.** This field day will be located at the National Muzzle Loading Rifle Association cafeteria building in Friendship, IN. This field day is designed for landowners, city officials, engineers, planners, landscape architects, conservationists and others interested in Streambank Stabilization and Habitat Restoration. Registration will begin at 8:00 AM. Speakers from different organizations such as IDEM and others will be present to answer any questions you may have and to provide useful information. The main objectives of the day will be permitting issues, what you can and can't do, and forms of streambank stabilization. For reservations please call the SLCWP at (812)689-6410 ext. 5. South Laughery Creek Cell Phone Drive

In today's society everywhere you look more and more people have cell phones. In many households these phones have become a means of life and as many as 158 million Americans now have their own cell phones. But what happens when you're ready for that upgrade? Where does your old phone go? Upwards of 100 million cell phones are replaced each year and more often than not they get disposed into a landfill. Cell phones contain many chemicals and toxins that affect our environment. They are made up of 40% metals, 40% plastics, and 20% ceramics and other trace materials. Toxins such as *cadmium* which is bioaccumulative, *lead* that accumulates in the soil and can cause damage to plants, animals and humans, *mercury* that turns into methylated mercury once in water and eventually ends up in our food, and *brominated flame retardants* that may increase the risk of cancer when consumed. When water leaches away from these landfills it carries these toxins with it. The overall message here is that landfills are not a great location for your old cell phone so we are offering another solution. Bring your old cell phones to the South Laughery Creek Watershed and help the project keep cell phones out of landfill while giving us an opportunity to raise money for the project.
